WHEREAS, Millville's Town Engineer has inspected said improvements and confirmed their completion; and

WHEREAS, the aforementioned developer has acknowledged the need to provide a one-year warranty bond, with said year starting on September 8, 2020, for the following improvements:

Pembroke Lane from Station 0+00 to 5+85.28 with 50' ROW Park View Street from Station 1+98.18 to 6+38.64 with 50' ROW Wild Air Way Street from Station 3+75.95 to 5+77.70 with 50' ROW Summerset Alley from Station 2+50.00 to 4+46.71 with 20' ROW Summerset Boulevard from Station 3+42.26 to 3+94.00 with 50' ROW

NOW THEREFORE, BE IT RESOLVED that the Town Council of the Town of Millville do hereby approve the release of Bond #PB03010403569 prepared by Philadelphia Insurance Company, subject to the aforementioned developer providing the required warranty bond in the amount of \$50,000.00.

BE IT FURTHER RESOLVED that, upon receipt of the required warranty bond, the Town Manager is authorized to provide a copy of this Resolution, inform the bond company of the bond's release, and take any other necessary actions to implement the terms of this Resolution.

BE IT FURTHER RESOLVED that, the Town Council of the Town of Millville approves transfer of improvements to the Sea Star Village Home Owners Association.
