This Ordinance removes the Town Code's prohibition on providing compensation to the members of the Planning & Zoning Commission. Last month, the Town Council passed Resolution 21-19, which permits the Town Council to establish stipends for the Planning & Zoning Commission and the Millville Board of Adjustment via the Town Budget process.
