If someone chooses to speak during the first Citizens' Privilege, he/she may not speak on the same topic during the second Citizens' Privilege. No member of the public may speak until recognized by the Mayor. No person shall be permitted to speak for more than three (3) minutes without the approval of the Mayor or a majority vote of the full Council. Members of the public shall address their remarks on issues of the public interest in the community, shall conduct themselves civilly, and shall not make personal attacks on any citizen or any Town employee or official. Notwithstanding these guidelines, the Mayor (or the Council by an affirmative vote of a majority of the members voting thereon of Council) may terminate further public comment on any particular topic where it appears that the comments are repetitive, abusive or otherwise making no contribution to the purpose of the meeting.
