The Town is seeking responsible bidders to fabricate and install a Double-Sided LED Message Board on the Town of Millville property.

Prospective bidders may pick up the description and minimum requirements of the sign at Millville Town Hall or by contacting the Code and Building Department at 302-539-0449 for an electronic copy. There will be a pre-Bid meeting on August 9th at 2:00 p.m. in Town Hall.

Responsive bids shall be submitted in a sealed envelope and shall be marked clearly as follows: **Sealed Bid - Double Sided LED Message Board, 24-05.**

Electronic LED Message Board

Minimum Requirements

The following is a list of minimum requirements needed with the Electronic LED Message Board.

1. Top sign will display "Town of Millville" using the Parks colors. The overall size for this sign should be 36" x 72". This sign will not be Electronic. It will be a Digitally printed image with the Town Seal.
2. Middle sign will be 4' x 6' 10MM Full Color LED Message Board
3. Bottom Directional Sign shall read "Evans Park" with an arrow pointing in the direction of the park. Park Colors. 18" x 72". This will be Digitally printed image as well.
4. All signs are double sided.
5. Sign will be supported by 3 pilings on each side w/rope decoration (Same as Town Hall), or the 3 pilings will wrap around the main supporting post to appear as they are the main supports.
6. Bottom of third sign will be 3' off the ground.
7. Software to operate the message board.

Provide Estimated completion date.

This sign will be installed at the corner of Atlantic Ave and Dukes Dr.

It will look similar to the Town Hall sign, however the colors will be of the park with the Town Seal.
