The site is located on Tax Map Parcel 134-15.00-120.01 and zoned Master Planned Community at Southwest of the intersection of Coastal Living Lane and Endless Summer Drive, Millville, DE 19967.

B. Discuss and consider possible recommendation of Annexation report for proposed Annexation submitted by Foxlane Homes of Delaware, LLC.

Synopsis: The proposed property consists of 4.989 acres located on Whites Neck Rd. Tax Map Parcel #134-12.00- 16.00, 1501.00, 1502.00, 1503.00, 1504.00, 1505.00, 1506.00, 1507.00, 1508.00, 1509.00, 1511.00,1512.00, 1513.00,1514.00, and 1515.00. The location is consistent with the Millville Comprehensive Plan and is contiguous with the Millville boundary line.
