<u>SYNOPSIS:</u> This proposed Resolution accepts the subject properties into the Town; the proposed Ordinance amends the Town's Future Land Use map with respect to the portions of the subject properties currently in Town limits to reflect residential use and amends the Town's official Zoning Map to designate the annexed areas as R1 – Residential District (formerly known simply as the "R – Residential District"). The proposed Ordinance has a delayed effectiveness to allow for compliance with the Charter's annexation process, specifically allowing the 30-day referendum period and requiring recordation of a description and plot of the newly annexed area.
