We have completed our review of the Village 6 MBTS Preliminary Site Plan, received by the Town of Millville April 9, 2025 for the 53 duplex village in Millville by the Sea. The site is located on Tax Map Parcel 134-15.00-119.00 and 134-15.00-120.00 and zoned MPC. The submission was reviewed per Town of Millville Code Sections 125, MBTS Development Standards and generally accepted engineering principles. Specific comments were made regarding individual components of the submittal and are discussed below.

## General

- 1. The proposed development is in line with the 2019 Comprehensive Plan future land use for the above referced parcel.
- 2. The proposed Village 6 MBTS has one planned entrance from "Future Connector to Roxana Road".
- 3. Sheets PSP2.0, PSP3.0, and PSP6.0: There is a duplicate T.P.# label for 134-16.00-17.01, please remove the extra label on the sheets listed.
