#### DEVELOPMENT ACTIVITY

MBTS PENINSULA VILLAGE: Developer still working on corrections to get off Bonds.

**MBTS SCHOONER COVE:** Developer still working on corrections to get off Bonds.

**VILLAGE 5:** This will be the next village on the east side once Belle Shoal (Village 4) is completed with the infrastructure.

**SEAGULL VILLAGE:** (Village 2) This development should be built out by July 1 and repair walks should start thereafter.

**BELLE SHOAL:** (Village 4) Groundwork still underway. Base blacktop is complete. Phase 1 is being built on. DelDOT only releases 15 permits for the time while Substation is being completed.

**WEST VILLAGE A-1:** Has started. Catch Basins along Peppers Corner Road are in for the entrance. Route 17 sewer is almost complete. A-1 and C-1 cannot move forward with sewer until Rte. 17 line is completed.

**WEST VILLAGE C-1:** Lift station completed; force main installed. Road cut in, water main being run and has been board under Powell Farm Road.

**TUPELO SANDS/ASCEND BY THE SEA:** Final Walk completed. Awaiting Sussex County Sewer sign off and this job will be completed.

**SUBSTATION RD.:** DELDOT continues. Base paving down, Touching up curds and multi-module paths for final topcoat.

**PARKSIDE:** This site is completed and ready to have bonds released.

**EGRET SHORES:** Housing construction well under way. West Side almost built out East side construction started. Khov goal is 1 house a week.

**TOOMEY PROPERTY:** (Westbury) Dirt being stockpiled. I do not know when they will start.
