**A RESOLUTION AUTHORIZING RENEWAL OF A MUNICIPALITY-WIDE DISCOUNT
AMBULANCE SUBSCRIPTION AGREEMENT WITH THE MILLVILLE VOLUNTEER FIRE
COMPANY FOR A THREE- YEAR TERM**

WHEREAS, the Town of Millville, pursuant to its Charter, has the power and authority to provide for the organization and the control and government of an ambulance service and emergency treatment service, as well as the power to donate an amount (not to exceed six percent (6%) of the total property taxes) unto, individually or in combination, volunteer fire companies and volunteer ambulance or emergency treatment service companies maintaining and operating ambulance, emergency treatment equipment and service to the Town; and

WHEREAS, the Town of Millville has previously entered into a Municipality-Wide Discount Ambulance Subscription Service Agreement with the Millville Volunteer Fire Company, Inc., and a new proposed agreement dated May 1, 2026 (“the Agreement”) that shall terminate on April 30, 2029; and

WHEREAS, under the Agreement, the Municipality agrees per year, to assess, by a means approved by the Municipality, a voluntary fee of \$50.00 per improved property inside the municipal boundaries, with properties improved by multiple units (such as condominiums, cooperatives, and shopping centers) being assessed the fee per occupied unit; and

WHEREAS, under the Agreement, the collected fees shall be remitted to the Millville Volunteer Fire Company, Inc., on an annual basis by October 1st, with the fees maintained in an account solely for said funds and utilized by the Millville Volunteer Fire Company, Inc. solely for the delivery of ambulance services; and

WHEREAS, the Town Council, pursuant to Section 30 of the Charter, each year must vote on the adoption of the Town budget, which shall include an itemized statement by the Town's chart of accounts of all estimated expenses to be incurred in the affairs of the Town for the ensuing fiscal year, and said budget shall be effective on the first day of the new fiscal year; and

WHEREAS, the Town Council has determined that continuing participation in said program serves the best interest of the public health, safety, and welfare of its residents; and

WHEREAS, the annual subscription renewal rate for participation in the program is Fifty Dollars (\$50.00) per residence and business for Fiscal Year 2027; and

WHEREAS, emergency medical services within the Town are provided in coordination with agencies such as Sussex County Emergency Medical Services and local fire and EMS companies;

NOW THEREFORE, BE IT RESOLVED that the Town Council of the Town of Millville does hereby direct the Town Manager to execute the three (3) year municipality-wide discount ambulance subscription agreement with the Millville Volunteer Fire Company.
