Candidates should also familiarize themselves with applicable ethical requirements, including those overseen by the Delaware Public Integrity Commission, if applicable.

Candidates are encouraged to review all materials carefully and to consult legal counsel or the appropriate state agencies if questions arise regarding eligibility, reporting, or compliance.
