SYNOPSIS: The application was submitted by Christopher Companies for property known as Coastal Farm (aka Flyaway Farms) received by the town on May 26, 2026, to annex into town limits. Town Council forwarded it to the annexation committee on June 9, 2026. The annexation committee met on June 16th and voted unanimously to move into next phase. Annexation committee met on July 21st and voted to move to Town Council. Town Council approved the report on August 11, 2026, voting 5-0 with roll call to move to Planning and Zoning. Planning and Zoning voted 5-0 on September 8, 2026, to approve RPC zoning and move to Town Council.

- B. Discuss, consider and possible vote on Resolution 27-10 regarding Evans Park grant submitted to ORPT for a total project amount of \$75,000 with the Town responsible for 50% of the project to spend towards concrete cornhole, gaming tables and sidewalks at Evans Park.
